About Mark

Mark has lived in Guildford for more than 40 years and been successful in achieving results for his Guildford South East Division, as well as the wider Guildford community.

His first simple objective was to ensure that the old highways contract was revised to deliver a better result. This was achieved within his first year as a County Councillor, and subsequently he spent six years on the Environment and Transport Scrutiny Committee, acting as its vice-chairman in 2014/2015.

For five years, Mark was also chairman of the Guildford Local Committee. He worked hard in this role to successfully unite SCC & GBC in shared projects for the benefit of the residents of Guildford.

These included highways resurfacing projects in and outside the town centre, including finding a means of funding the relaying of the High Street setts, as well as a pilot project to address school safety and antisocial parking outside three schools, Boxgrove school, St Thomas's school, and St Peter's, with additional funding secured to address similar issues outside three schools in West Guildford.

Mark also worked on identifying a way of creating cycle paths from East to West across Guildford to create meaningful routes replacing the old patchwork network, with the first stage having been designed and awaiting appropriate funding to proceed.

Since 2015, Mark has been chairman of the Surrey County Council Education and Skills Board, looking at all aspects of education that affect residents in Surrey, from early years, through school years to adult education.

Mark is committed to fighting for the issues that affect our community, and looks forward to continuing to do so with your support in the future.

Road and pavement improvements

Highways and pavements affect all people living in an area, the nature of this vital part of the built environment reflecting the way an area perceives itself, becoming a physical representation of a community's priorities.

The state of the pavements and roads, therefore, is an important expression of a community's wellbeing.
